TO APPLY, FOLLOW THESE STEPS:

1. The new heating system must be purchased and installed by April 30, 2020.
2. Confirm that the project qualifies for this rebate by reading the terms and conditions on this page. Contact a Seattle City Light Energy Advisor at (206) 684-3800 or visit seattle.gov/appliances if you have any questions.
3. Heating system installer must be a Northwest Ductless Heat Pump Project participant and exhibit familiarity with the program.
4. This rebate is to be awarded directly to the Seattle City Light customer. Customers may arrange to assign the rebate check to the installer by completing the Assignment of Rebate Payment to Contractor section on page 3.
5. Complete this form and email or mail within 90 days of purchase including the system purchase receipt and/or project invoice.

TERMS AND CONDITIONS

Please refer to the following terms and conditions prior to signing acceptance:

- Rebate applicants must be a Seattle City Light (SCL) customer and the installation address must be in the SCL service area. To qualify, residence must be an existing single-family (includes 1-4 unit buildings) that is at least 1 year old. Multifamily units do not qualify.
- Customers are required to provide the SCL account number for the address where the system is being installed. Landlords are not required to provide an account number. Applications without an account number may be denied if SCL cannot verify applicant as a customer or property owner.
- Current primary heating source must be electric forced air furnace or electric resistance zonal heat (for example: electric resistance baseboards, Cadet or King wall heaters, hydronic baseboard heaters, or space heaters). Homes with gas furnaces or oil heat, are not eligible.
- The installed heat pump system must meet the following qualifications:
 - Equipment needs to employ an inverter-driven outdoor compressor, with inverter-driven or variable-speed indoor blowers and use R410A refrigerant. Minimum HSPF ratings are 11.0 for DHP upgrades and 9.0 for all other system types.
 - Equipment must be on the SCL Qualified Projects List and installed per manufacturer's specifications by a participating Program Contractor. A list of participating contractors and qualified equipment can be found at seattle.gov/appliances.
- Rebate is not available for Variable Refrigerant Flow (VRF)/Variable Refrigerant Volume (VRV) systems.
- All information must be complete and a copy of receipt or invoice, must be enclosed to be considered for payment.
- One rebate per household.
- Prior to submitting this rebate, products must be installed and functional. Equipment must be purchased and installed by April 30, 2020. This rebate application must be postmarked within 90 days of the installation date.
- Rebate applications submitted by contractors may be submitted digitally with digital signatures. Contractor must submit a digital signature audit trail along with completed application.
- It is SCL's intent to mail the appropriate rebate check within sixty days of SCL's receipt of a completed application. Lack of documentation or information from the Program Participant to SCL will delay rebate processing.
- This rebate form and program documentation is subject to Washington's Public Records Act, RCW Chapter 42.56.

By submitting this rebate form Program Participants recognize that prior to payment SCL may contact the applicant, related vendor or installer to evaluate installation information, inspect the installed product listed on this form, and request the Program Participant to submit supporting documentation. SCL will review the project to determine eligibility and qualification for a rebate in accordance with these terms and conditions. This program is completely voluntary, and Program Participant assumes any risks of injury, property damage, and expenses that may arise during the implementation of these energy conservation measures.

SCL does not make any representations, promises, or warranties for any efficiencies of potential energy savings, installed products, materials, equipment fitness, labor required, or merchantability for any purpose. Program Participant represents and warrants that all installed requirements are in compliance with all applicable federal, state and local laws, codes, ordinances, including all building energy and accessibility codes and in compliance with these terms and conditions.
